Thank you for visiting Dar Al Jumuah Publishing & Distribution (our website “membership.aljumuah.com”), which is owned and operated by Dar Al Jumuah Publishing & Distribution, LLC. and its affiliated companies (collectively “Dar Al Jumuah Publishing & Distribution”). We’re updating our Policy as of **March 27, 2019**. Here are some of the changes you’ll see we’ve updated the Policy to reflect changes in data privacy laws.

This updated privacy policy more clearly explains how we use your information. Our commitment regarding your privacy has not changed, including the commitment to never sell your data.

The privacy policy explains the information Dar Al Jumuah Publishing & Distribution collects from you, how we use that information and our legal basis for doing so. It also covers whether and how that information may be shared and your rights and choices regarding the information you provide to us.

Information and data processing practices

Dar Al Jumuah Publishing & Distribution collects information from you when you register on our site, place an order or complete a form. By submitting your personal information, you are agreeing that Dar Al Jumuah Publishing & Distribution may collect, store, use, disclose and destroy it in accordance with this policy.

What information do we collect?

Dar Al Jumuah Publishing & Distribution collects personally identifiable information (pii), such as your name, email address, physical address, and credit card or debit card information should you become a registered member. You may, however, visit our site anonymously. Depending on your use of the services, that may include:

- Information you provide by registering on membership.aljumuah.com— your name, email and postal addresses, telephone number, country of residence, login, and password details. We may ask for this information if you register as a user of membership.aljumuah.com or if you contact us;
- Dar Al Jumuah Publishing & Distribution may also collect anonymous demographic information, which is not unique to you, such as your age and gender. We may gather additional personal or non-personal information in the future.
- Details of any requests or transactions you make through the membership.aljumuah.com, Dar Al Jumuah Publishing & Distribution partners with other companies (such as Stripe and/or PayPal) for payment processing, and the payment information you submit is collected and used by them in accordance with their privacy policies.

- Information about your activity on and interaction with membership.aljumuah.com, including use of our mobile apps (such as your IP address, the type of device or browser you use, and your actions on the Site);
- Information about the ways people visit and interact with our site, in the form of traffic analytics. You can opt out of being included in [Google Analytics here](#).;
- Communications you send to us (for example, when you ask for support, send us questions or comments, or report a problem);
- Information that you submit on or to membership.aljumuah.com in the form of comments, contributions to discussions, or messages to other users; and
- Information about your computer hardware and software may be automatically collected by Dar Al Jumuah Publishing & Distribution. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the membership.aljumuah.com website.
- Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Dar Al Jumuah Publishing & Distribution public message boards, this information may be collected and used by others.
- Dar Al Jumuah Publishing & Distribution encourages you to review the privacy statements of websites you choose to link to from Dar Al Jumuah Publishing & Distribution so that you can understand how those websites collect, use and share your information. Use of Cookies

The Dar Al Jumuah Publishing & Distribution website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Dar Al Jumuah Publishing & Distribution pages, or register with Dar Al Jumuah Publishing & Distribution site or services, a cookie helps Dar Al Jumuah Publishing & Distribution to recall your specific information on subsequent visits. European Union Users

Retention

We will retain your information as long as your account is active, as necessary to provide you with the services or as otherwise set forth in this Policy. We will also retain and use this information as necessary for the purposes set out in this Policy and to the extent necessary to comply with our legal obligations, resolve disputes, enforce our agreements and protect Dar Al Jumuah Publishing & Distribution's legal rights.

We also collect and maintain aggregated, anonymized or pseudonymized information which we may retain indefinitely to protect the safety and security of our Site, improve our Services or comply with legal obligations.

Your Rights

Users residing in certain countries, including the EU, are afforded certain rights regarding their personal information. Except where an exception or exemption applies, these rights include the ability to access, correct, and request deletion of your personal information. While these rights are not applicable globally, all Dar Al Jumuah Publishing & Distribution users can manage their personal information, as further described below, in their account settings.

Email and Mobile Notifications

Security

Dar Al Jumuah Publishing & Distribution secures your personal information from unauthorized access, use or disclosure. We take security seriously, and the security of your personal data is important to us. We follow industry-standard practices to protect the data we collect and maintain, including using Transport Layer Security (TLS) to encrypt information as it travels over the internet. No method of transmission over the internet or electronic storage is completely secure, so Dar Al Jumuah Publishing & Distribution cannot guarantee its absolute security. Your account information is protected by a password, which you should choose carefully and keep secure.
