1. Welcome to Dar Al Jumuah Publishing & Distribution! This page explains our terms of use. When you use Membership website, you're agreeing to all the rules on this page. The Dar Al Jumuah Publishing & Distribution Company website (the "Site") is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms").
